It gives me great pleasure to announce that the Management of Tone Group has confirmed the Incentive Trip destinations for the year 2018. They are as follows:

1. TURKEY
2. SRI LANKA

The following criteria apply for qualification:-

CRITERIA :-

TURKEY

- (1) Qualification period from 1st November 2017 to 31st July 2018
- (2) Accumulative Purchase of 3,199 SIM cards

ENTITLEMENT: 1 x 9 Day Tour Package to TURKEY with pocket money of RM2,000/= per person

SRI LANKA

- (1) Qualification period from 1st November 2017 to 31st July 2018
- (2) Accumulative Purchase of 1,799 SIM cards

ENTITLEMENT: 1 x 5 Day Tour Package to SRI LANKA with pocket money of RM800/= per Person

Other Terms & Conditions :-

- Ticket & Cash Allowance Entitlements are not transferrable to non-members. Each ticket entitlement is linked to a single account and is not a cumulative total of several accounts.
